The New Mexico Department of Game and Fish (Department) has reviewed the above referenced permit modification. Rammsco Operations, Inc. (Rammsco) is requesting the partial release of financial assurance associated with approximately 2.1 acres of reclamation work that included backfilling, recontouring, ripping, and seeding. Rammsco is also proposing to expand mining operations and disturb no more than 6.6 additional acres within the mine permit area. Staff from the Department, MMD, New Mexico Environment Department, and Rammsco conducted a site inspection on 28 August 2024.

Department staff observed that the disturbed mine pit area had been backfilled, recontoured to conform with the surrounding habitat, ripped, and seeded. Rammsco has also incorporated small depressions and berms within the reclamation site to hold and contain water for longer periods of time following precipitation events. Seeding had been performed approximately three weeks prior to the site inspection, and the reclamation site was already exhibiting significant germination of grasses and forbs. The Department does not have any issues with the requested partial release of financial assurance or the proposed expansion of mining operations.

The noxious weed halogeton (Halogeton glomeratus) was observed within the mine permit area. The Department recommends that Rammsco continue to implement a weed monitoring program and maintain their commitment to aggressive control of halogeton within the mine permit area.

On August 20, 2024 the Surface Water Quality Bureau (SWQB) received a request for comments regarding the subject permitting action for the Eagle Mesa Mine operated by RAMMSCO Operations, Inc. (RAMMSCO) located in Sandoval County, New Mexico on land administered by the U.S. Bureau of Land Management. Modification 24-1 proposes a partial release of Financial Assurance for the reclamation of 2.12 acres and 6.6 acres of expanded mining operations within the permit area. Pursuant to 19.10.12.1210 New Mexico Administrative Code (NMAC), SWQB has prepared the following comments:

The Eagle Mesa Mine is located within the 12-digit Hydrologic Unit Code 130202050403 named "Outlet San Isidro Wash" which is a tributary to Torreon Wash, Arroyo Chico, the Rio Puerco, and ultimately the Rio Grande. San Isidro Wash and its tributaries are subject to 20.6.4.98 NMAC (State of New Mexico, Standards for Interstate and Intrastate Surface Waters) and have designated uses for livestock watering, wildlife habitat, marginal warmwater aquatic life, and primary contact. Surface waters of the state shall be free of any water contaminant in such quantity and of such duration as may with reasonable probability injure human health, animal or plant life or property, or unreasonably interfere with the public welfare or the use of property (20.6.4.13 NMAC). Mining activities that have the potential to release water contaminants, including sediment, must be implemented with practicable Best Management Practices (BMPs) to prevent impacts to surface water quality. Practicable BMPs include, but are not limited to, maintaining and inspecting equipment daily to prevent leaks, using appropriate storage containers for fuel and chemicals, refueling away from watercourses, having spill cleanup kits on-site to be used in the event of a spill, maintaining roads, berms, sediment basins, stormwater ponds, silt fencing, and achieving revegetation success as soon as possible. Additional stormwater and erosion control structures will need to be installed in the expanded mining area. Any discharge of a water contaminant, in such quantity as may with reasonable probability injure or be detrimental to human health, animal or plant life, or property, or unreasonably interfere with the public welfare or the use of property, must be reported to the Environment Department within twenty-four hours (20.6.2.1203 NMAC).

Thank you for the opportunity to comment on the above referenced project. There is the potential for impacts to *Sclerocactus cloverae* (Clover's cactus), a State Endangered plant species listed in Section 75-6-1 NMSA 1978.

Although no occurrences of *Sclerocactus cloverae* are currently known from within project boundaries, the site occurs 10.5 miles southwest of known populations and contains suitable habitat for the species: sandy clay strata of the Nacimiento Formation between 1,500 and 2,200 m (4,921–7,217 ft) in elevation. As such, a plant survey conducted by an experienced biologist, botanist, or other appropriate consultant is recommended to determine if the species listed above is present in proposed areas of new disturbance. If *Sclerocactus cloverae* is found and project activities will impact individuals, an incidental take permit from the New Mexico Forestry Division may be required. Thank you for submitting the request for comments on Modification 24-1, Eagle Mesa Mine, Permit No. SA009MN, Rammsco Operations, Inc. to the New Mexico State Historic Preservation Office (SHPO) for review and comment. We received the information on August 16, 2024, via email.

A review of our database indicates the area has been previously surveyed. Two sites are within the proposed expansion area. One is eligible for listing in the National Register of Historic Places (NRHP) under criterion a. The second site is potentially eligible for listing in the NRHP. The BLM has recommended the sites be fenced for avoidance.

A review of the area of expansion presented in the 2024-07 Site maps, Modification Application Eagle Mesa 24-1 indicates the expansion is within lands owned by the BLM. I recommend contacting the BLM in regard to this project.
