The New Mexico Mining and Minerals Division ("MMD") has finished review of the permit application and all subsequent submittals for the Deming Alpha Mine, Minimal Impact New Mine Permit No. LU042MN, and has determined that the application is complete and approvable. Please find enclosed Permit No. LU042MN as approved by the MMD Director on January 28, 2025. With this permit, Gila Mining, LLC, is authorized to proceed with mining operations as outlined in the document. The current term of the permit is until January 28, 2035. The term of the permit, renewal of the permit, and any review of the permit by MMD is governed by 19.10.6.607 NMAC.

Please note that in accordance with 19.10.6.610 NMAC, Gila Mining is required to submit an annual mine report as follows:

"19.10.6.610 ANNUAL REPORT: Every permittee, including those holding minimal impact mining permits, shall, on or before April 30 of each year after a permit has been issued, submit, on a form provided by the Director, a report for the preceding calendar year. The report must:

- *A.* provide the status of the operation;
- *B.* provide production figures for the operation;
- *C. identify, on a separate map, the location of the disturbed areas and if reclaimed, the year in which the work was done;*
- *D. identify the number of acres disturbed, the number of acres reclaimed during the reporting year and the number of acres which have not yet been reclaimed;*
- *E. indicate the current market value of any collateral posted as financial assurance in accordance with Part 19.10.12 NMAC; and*
- *F.* indicate the compliance status for all existing state and federal environmental permits held by permittee for this operation."

The annual report form can be found on the MMD website here: <u>https://www.emnrd.nm.gov/mmd/mining-act-reclamation-program/</u>. Per 19.10.2.202.D, this permit is also subject to an annual fee of \$250.00. Please submit this fee at the same time as the annual report.
